




## Growth of a \$10,000 Investment Since Inception (July 26, 2018 to January 31, 2026)

This is through investments in securities or derivatives-like futures, swaps, or options-either directly or indirectly through Fortress Fund Ltd, a wholly owned subsidiary of the Fund organized under the laws of the Cayman Islands (the "Subsidiary"). <sup>6</sup>Alpha is a risk-adjusted performance statistic used to evaluate how good a job an investment manager has done, i.e. how much value he or she has added over and above the return provided by the market over a specific time period. Beta is a measure of a portfolio's sensitivity to market movements (as represented by a benchmark index). The benchmark index has a beta of 1.0. A beta of more or less than 1.0 indicates that a fund's historical returns have fluctuate more or less than the benchmark index. Beta is a more reliable measure of volatility when used in combination with a high R<sup>2</sup> which indicates a high correlation between the movements in a fund's return and movements in a benchmark index. R<sup>2</sup> can help investors assess the risk-return profile of investments. Together with alpha and beta, it provides a snapshot of a fund's returns versus the return of a benchmark index. It measures the strength of the relationship between a fund's performance and a benchmark's performance, specifically, the degree to which a fund's performance can be explained by the performance of the benchmark. The Sharpe Ratio uses 0.78% as the risk free rate, which is determined by the 90-day T bill rate for the period. A Sharpe Ratio is a measure of historical risk-adjusted performance describing how much excess return you receive for the volatility of holding a riskier asset. The Sharpe Ratio measures the performance of an investment compared to a risk-free asset. The higher the ratio, the better the fund's return per unit of risk. Standard Deviation measures the dispersion or spread of a fund's returns around its average return over a certain period of time. In this case, it is computed using trailing monthly total returns for the last 3 years, then annualized, and finally expressed as a percentage. It is recognized as a measure of risk in the financial industry. Max Drawdown is the maximum peak-to-trough decline during a specific period for an investment fund or trading account.
